- 2) Public Auction will be conducted at **State Department of Roads (Mechanical and Transport Division Parking yard -Machakos Road, Industrial Area, Nairobi, Friday, 7th March 2025** starting at **10.00a.m.**

- 3) Interested bidders are required to pay a refundable deposit of **10% of the reserve price as indicated in the catalogue for each motor-vehicle** to get a bidding number. The deposit shall be paid in form of cash at the **Cash Office** of the State Department of East African Community, located on **16th Floor Co-operative House Building, along Haile Selassie Avenue, Nairobi** during normal working hours from **9.00 a.m. to 12.30 p.m.**
- 4) The interested bidders are required to register their details as per the Disposal Register Provided.
- 5) All lots bid and fully paid for must be collected within thirty (30) days failure to which the purchaser shall be liable to pay a storage charge of Kshs.1,000/- per day.
- 6) The vehicles shall be sold on AS-IS-WHERE-IS basis.
- 7) The declared purchaser (highest bidder) **MUST** pay 25% of the purchase price in cash for the lot bid for and the balance must be paid in cash within seven (7) days from the Auction date, failure to which the initial deposit will be forfeited and the vehicle offered to the second highest bidder.
